

**Requirements  
for the papers submitted for publication in  
the Scientific Bulletin of Cahul State University “Bogdan Petriceicu Hasdeu” (CSU)**

The submitted papers must reveal the scientific achievements of the teaching staff of CSU's departments and researchers from other institutions as well. A person can be the author and/or co-author of one article.

The responsibility for the correctness, authenticity, and scientific value of the submitted materials lies with the author(s). The author(s) will present a Declaration of Originality concerning the uniqueness of the proposed scientific article.

The final decision on the inclusion of papers and editing of each issue of the Bulletin belongs to the Scientific Editorial Board of CSU.

The structure of the scientific papers includes the following compulsory components: abstract, keywords, main text, and references.

The titles, the summaries, and the keywords in the articles must be written in two languages: in Romanian and in a foreign language.

The texts of the scientific articles can be written in Romanian, Russian, English, French, or German.

The paper is submitted in electronic form, in Microsoft Word format, together with a printed version signed by the author(s).

**Publishing requirements:**

- **TITLE** – is written with capital letters;
- **Author's full name** - first name and LAST NAME;
- **Affiliation** – the authors will present the full name of their institution and chair/department. Abbreviations are not allowed. They will also indicate their email address;
- **Summary** - up to 300 words;
- **Text** – the text volume will not exceed 15 pages;
  - Page format B5 (ISO) 17.6 x 25 cm;
  - Font Times New Roman;
  - Font (letter) size 11, interval between lines - 1, left paragraph indentation at: - 1cm;
  - Page settings: top - 1,8 cm, bottom - 2 cm, left – 2,5 cm, right - 1,5 cm;
- **References in the text**
  - Each piece of work cited within the text is identified by an Arabic number inside square brackets, e.g. [7]. The numbers are assigned in the order of citation;
  - If a piece of work is cited more than once, the same citation number must be used;
  - If you are citing multiple sources within a single parenthetical reference, the numbers are classified in ascending order and separated by commas, for example [1, 6, 9];

**References in the reference list**

- The entries in the reference list are placed in the same order in which they were cited in the text;
- It is recommended to see the rules set out in the “PhD thesis editing guidance” approved by the Commission Decision of National Council for Accreditation and Attestation of the Republic of Moldova. - **Figures, photos, and tables** are placed directly after the reference in the text;
  - The table name and number are placed above the table;
  - The figure or photo name and number are indicated below the figure.

**The papers that do not respect the style, grammatical rules, and the requirements written above will be rejected.**
